



YOUNG PROFESSIONAL MEMBERSHIP AGREEMENT

As a member of Desert Blume Golf Club, each paid membership is entitled to:

- Unlimited golf privileges including shared power cart
- Seven (7) day advanced booking
- Unlimited use of the Golf Academy (driving range, chipping green and putting green)
- Club storage
- Full locker room privileges including steam room
- Charging privileges on-course, dining facilities and golf shop (with valid credit card information on file)
- Participation in all annual Club events and tournaments
- Golf Canada Handicap – Golf Membership

Members of Desert Blume Golf Club are required to follow all Policies and Procedures outlined by the Club in its code of conduct, bylaws and rules including, but not limited to:

- Canceling unwanted tee times 24 hours in advance of the reserved time
- Dress code - no denim, tank tops, sweat pants/shorts, collared shirts preferred

The Manager reserves the right to refuse or terminate play for anyone breaching club rules.

Definitions & Conditions of the Introductory Membership

- Approval of any persons as a **Young Professional Membership** holder shall be at the discretion of Desert Blume Golf Club Ltd. ("Manager") its employees or agents and contractors retained to manage the Club who may refuse or deny an application for membership or renewal and who may suspend or terminate participation if deemed necessary.
- Upon application acceptance, the **Young Professional Member** acknowledges and agrees that:
 1. The Manager is not responsible for any loss or injury to self, guests or family while in, on or about the premises of the Club (including the course, clubhouse and parking facility) and the **Young Professional Member** hereby waives any and all claims and rights of damages against the Manager, its agents, employees, etc, accordingly;
 2. The **Young Professional Membership** program is outlined as follows:
 - Young Professional aged 19-30 pays tier 1 price as determined by society and the manager of the club. **\$500** of the yearly payment will be applied towards the purchase of an equity share until the equity share is paid for at the posted rate.
 - Young Professional aged 31-35 pays tier 2 price as determined by society and the manager of the club. **\$500** of the yearly payment will be applied towards the purchase of an equity share until the equity share is paid for at the posted rate.
 - Young Professional fees include \$100 levy fee which is collected on behalf of the Desert Blume society. Upon receipt of the share certificate the member may attend the annual AGM and have full voting rights.
 - Young Professional member can have a spouse and children under their share at the discounted fees while in the program at the posted rates that are determined by the society and the manager of the club each year.
 - Young Professional member can have their children play for free if their spouse pays their dues for the year.
 - Young Professional member will receive 2 green fee passes with carts to use at their discretion.
 - At the end of program, the Young Professional will receive an equity membership certificate and continue as an Equity Member paying annual dues.
 - Members participating in the Young Professional Membership Program will receive a 50% buy back of their equity share, subject to the terms of the club bylaws.

- 4. Charging privileges are allowed on the condition that the Member is in good standing, provides current credit card information and authorizes any amount due on the member account be charged to the credit card on or before the 22nd of month following and by signing authorization on reverse of this Agreement;
- 5. Desert Blume management reserves the right to close to the public, at its discretion, for the purpose of tournament play;
- 6. All non-sufficient fund (NSF) cheques incur a twenty-five (\$25.00) dollar service charge.
